Terms of Promotion "31 days for free"



applicable from September 1, 2021 until October 31, 2021

"31 days for free" is a promotional service (hereinafter: "Promotion") available to Subscribers (hereinafter "Subscribers") of the Orange Free, Orange YES, Orange POP tariffs. Within the Promotion Subscriber receives a free service "No limit calls, text and multimedia messages to everyone + 15GB package" for the period of 31 days after the first top up with an amount of min. PLN 5. The Promotion requires activation via free text message.

Promotion Details

- 1. The Promotion is available to Subscribers between September 1, 2021 to October 31, 2021.
- 2. Within the duration period of the Promotion, Subscriber who activates an Orange starter, transfers a phone number from a different network or moves from a subscription offer to a pre-paid offer in Orange or from nju mobile to Orange pre-paid offer can use the promotion for the service "No limit calls, text and multimedia messages to everyone + 15GB package" valid for 31 days.
- 3. The service activation cost is PLN 0.
- 4. In order to use the Promotion, the account shall be topped up within the promotion duration with the amount of min. PLN 5 by any top up means subject to item 5. followed by sending a free text message START to number 813.
- 5. Special topups available at www.doladowania.orange.pl, which are automatically replaced with the "No limit calls, text and multimedia messages to everyone + GB package" are not covered by the Promotion.
- 6. Within the Promotion duration the Subscriber can use it once for the given phone number.
- 7. The Promotion shall be activated at the latest within 24 hours from the time of the activation text message is sent, on the condition that the account has been previously topped up, according to item 4 above. A return text message is a confirmation of the Promotion activation.
- 8. The Promotion will be activated automatically and it will remain active on the given Subscriber's phone number for 31 full days until 11:59:59 p.m.
- 9. A 3.5 GB package is provided within the data roaming in Zone 1.
- 10. The conditions for activation of the Promotion are: the Subscriber's phone number must remain within the Active period (outgoing voice calls enabled), performing a top up of min. PLN 5 and sending the activation text message. The topup must be performed before the activation text message is sent.
- 11. The promotion is not available to customers who have the "No limit calls, text and multimedia messages to everyone + GB package" and "No limit calls and text messages to everyone + GB package" services active in a single and cyclic version.
- 12. The service validity period and the number of remaining resources resulting from the Promotion can be checked by sending a text message ILE to number 630 (cost of the text message according to the Subscriber's tariff plan).

Other information

- 13. Tariff change to another one, in which the Promotion is available does not result in deactivation of the Promotion.
- 14. Tariff change to another one, in which the Promotion is unavailable results deactivation of the Promotion.
- 15. The Promotion cannot be used by Subscribers using the Extra Number service and the Always No Limit tariff.
- 16. If the Customer has bonus gigabytes on their account resulting from the "Free Internet" service, from online topups, start bonus received after starter activation or other bonuses, they will be used prior to the Promotion gigabytes package.
